

<b>Dental – Extended Benefits Provision</b>	<p>The Extended Dental Benefit Provision under the MBF Dental Coverage provides coverage for up to 3 additional months after the date coverage ends for the member and/or covered dependent (spouse/domestic partner and/or child under age 26).</p> <p>Listed below are the 7 covered dental services that fall under this provision, as follows: 1) Fixed Bridgework 2) Full and Partial Dentures 3) Implants 4) Crowns 5) Inlays 6) Onlays 7) Orthodontic Treatment</p> <p>A dental claim for pre-certification for any of the above dental services would have to be approved by the MBF Dental Administrator <b>on or prior to 7/19/2024 (Friday)</b>.</p> <p>Also, in lieu of the Extended Dental Benefit Provision, the member and/or covered dependent can extend MBF Dental Coverage for up to 36 months under MBF Direct-Pay COBRA.</p> <p>Any other dental claims incurred <b>on or after 7/20/2024</b> will not be covered under MBF.</p> <p>Any expenses incurred on or after the member's/dependent's termination date from MBF will not be covered by MBF.</p>
<b>Group Universal Life Insurance</b>	<p>If you enrolled in the GUL program prior to termination with MBF, your GUL coverage will be converted from a group to an individual policy. You will be notified by Prudential automatically of the option to continue on a direct bill basis as a terminated member. <b>Superimposed Major Medical Plan (SMMP)</b>	<p>Please note that any SMMP claims incurred <b>on or after 7/20/2024</b> will not be covered under MBF.</p> <ul style="list-style-type: none"> <li>- Any claims incurred prior to the termination date can be submitted to SMMP. <b>MBF Health and Fitness</b>	<p>Please note that any Health and Fitness claim periods including the date of 7/21/2024 or later will not be covered under MBF.
